SUBJECT: Purchase Authorization for AEDs, Chest Compression Device and Cardiac Monitor

REQUEST:

City Council is requested to authorize the purchase of twelve (12) Automated External Defibrillators (AED), One (1) Automatic Chest Compression Device and One (1) Cardiac Monitor to Physio-Control, Inc., Redmond, Washington in the amount of \$91,987.72.

REASON FOR PURCHASE

The Rochester Hills Fire Department is equipping a reserve ambulance as an Advanced Life Support (ALS) unit with the purchase of the cardiac monitor and chest compression device. The purchase of the twelve (12) AED units is scheduled replacement/upgrade of the defibrillators. The City is trading in seven (7) of the AEDs being replaced. The remaining five units will be transferred to Fire Department administrative vehicles.

The Rochester Hills Fire Department has standardized its cardiac monitoring equipment to Physio Control, providing uniform operable heart monitors/defibrillators throughout the City and with local hospitals. The Physio-control Lifenet system, a hospital based monitor integration program, allows the Rochester Hills Fire Department to transmit cardiac diagnostic readings to local hospitals including Crittenton Hospital Medical Center, William Beaumont Troy, and St. Joseph Mercy Hospital in Pontiac, displaying for the hospital a heart patient electro cardio gram (EKG) allowing the hospital to work with Rochester Hills Fire Department in the pre-hospital environment and preparing the hospital for a cardiac patient's arrival and more efficient care and speedy transfer to a cardiac catheterization lab.

Physio Control is the sole source provider of Lifepack/Lucas equipment. As sole source provider, the City negotiated with Physio-Control to achieve a 17-18% discount off of list price for the products.
