**SUBJECT:** Purchase Authorization for One (1) Forklift

#### **REQUEST:**

City Council is requested to authorize the purchase of one (1) Forklift from Bell Forklift, Clinton Township, MI in the amount of \$37,270.00.

## **REASON FOR PURCHASE:**

The City issued an Invitation to Bid for one forklift utilizing the MITN system. The solicitation was distributed to twenty-five potential vendors. Three bid responses was received. The responses were reviewed by the Department of Public Services Fleet Department. OCTANE Forklift submitted the low bid. As Purchasing and Fleet staff are unfamiliar with this product, Purchasing requested from the vendor the name(s) of local authorized parts and service dealer(s). OCTANE Forklift did not respond to the information request. Due to the lack of response from the vendor, OCTANE Forklift was deemed non-responsive.

The second lowest bid received from Bell Forklift proposed a Toyota and met specifications.

This forklift will be replacing our 1991 Toyota forklift (39-08). The forklift is used at DPS for loading and unloading deliveries, moving material in the yard and for installing snow removal equipment on trucks.

Award is recommended to Bell Forklift as both a responsive, responsible vendor meeting specification and in the best interest of the City.
