REQUEST:

The Department of Public Services recommends that the Rochester Hills City Council approves the attached proposal for Construction Engineering Services for the DPS Salt Storage Facility project from Orchard, Hiltz & McCliment, Inc. (OHM) in the amount of \$40,000.00 for a new not-to-exceed amount of \$104,000.00 and authorizes the Mayor to execute a contract on behalf of the City.

REASON FOR PURCHASE:

OHM will provide construction engineering services to the City for the Salt Storage Facility Project. OHM is one of three consultants retained by the City to provide these services in accordance with our Professional Engineering Services Contract. OHM completed the construction plans and specifications for the project and is proposing part-time inspection services as required for the project. Some portions of the project (e.g. sewer construction, water main relocation) will be inspected by DPS inspection staff.
