SUBJECT: Solid Waste Contract

REQUEST:

City Council is requested to decide whether to approve the negotiated 5-year Contract Extension for Solid Waste, Yard Waste and Recycling Collection, Transportation and Disposal Services with Allied Waste Services of North America, LLC dba Allied Waste Services of Detroit North, Republic Services of Southeast Michigan (Republic Services), Pontiac, Michigan or direct administration to initiate a Request for Proposals for a new solid waste hauler contract.

City Council is requested to waive Section 2-273(b) the 3-year requirement for long term contracts, under Section 2-281, which allows City Council the authority to waive any regulation or procedure pertaining to purchasing, deeming it to be in the best interest of the City to allow a 5-year contract.

REASON FOR PURCHASE:

The City solicited through a Request for Proposals process solid waste, yard waste and recycling collection, transportation and disposal services. A contract was approved by City Council and executed on December 4, 2008, with Republic Services. The contract will expire on March 31, 2014. Under the terms of the contract, "the City and the Contractor may agree to extend the contract for an additional five year term."

The Solid Waste Committee considered re-negotiation of the contract, as well as soliciting a new Request for Proposals. The committee with the help of an industry expert reviewed programs in other communities and market trends within the industry. A contract extension was re-negotiated with Republic Services. The Amended and Re-Stated contract is included in the packet. The decision before City Council is whether to accept the contract or direct administration to solicit a Request for Proposals.

An outline of the City's current program and the future program enhancements, as negotiated, is included.
