SUBJECT:	As-Needed Construction Inspection and Surveying Services

REQUEST:

City Council is requested to authorize a blanket purchase order increase of \$135,000 for as needed construction inspection and surveying services to Spalding DeDecker Associates, Inc., Rochester Hills, Michigan and Nowak & Fraus, Pontiac, Michigan in the amount not-to-exceed \$375,000 through March 31, 2020.

REASON FOR PURCHASE:

Due to the number of private development projects that commenced late in the 2019 construction season, an increase to the existing blanket purchase order for construction inspection and surveying services is needed. The projects have been challenging this season, some larger in size, thus taking longer to complete. The increase is an estimate based on the assumption that the projects will continue through the winter.

Construction inspection services performed on private development projects are pass-through in nature, meaning that offsetting private developer escrow funds will be charged as revenues to offset the private inspection services expenditures. Services for this blanket will be mainly for private projects but may be utilized for public projects if the need arises.
