#### Michigan Public Act 325 of 2018


An Act to amend 1951 PA 51

- Requires local road agencies responsible for 100 or more certified miles of road to submit an asset management plan to the Transportation Asset Management Council (TAMC)
- Rochester Hills is required to submit a transportation asset management plan to the TAMC by October 1, 2021

An updated plan is to be released every three (3) years

#### **Asset Inventory**


- The City is responsible for maintaining and operating:
  - Over 266 centerline miles of roads
    - City major: 45.8 centerline miles
    - City local paved: 199.8 centerline miles
    - City local unpaved: 21.1 centerline miles
  - 4 bridge structures
  - 237 storm culverts
  - 13 traffic signals (with an additional 55 traffic signals coown/share in cost of maintenance)
- This plan identifies the condition of the city's assets, as well as the strategy the city uses to maintain and improve particular assets given the city's goals, priorities of road users, and resources.




City major = blue City local paved = green City local unpaved = red


# **Condition: Road Assets**

- Paved roads in Michigan are rated using the Pavement Surface Evaluation and Rating (PASER) system.
  - 1-10 scale: 10 being a newly constructed surface and 1 being a completely failed surface
  - PASER scores are grouped into TAMC definition categories:
    - ▶ Good (PASER scores 8-10) in green
    - ▶ Fair (PASER scores 5-7) in yellow
    - Poor (PASER scores 1-4) in red






#### Condition: City Major Road Network



Spending on projects depends on revenues from Michigan Transportation Fund, city contributions, and federal/state programs.

## Condition: City Local Road Network




Spending on projects depends on revenue from millages and city contributions.

- One (1) millage up to 1.0965 mill
- The city invests \$5,000,000 annually into its local road network


#### Goals

#### City Major Road Network

- Prevent its good and fair (PASER 10-5) roads from becoming poor (PASER 4-1)
- Move 3% of the road network out of the poor category




- City Local Road Network
  - Prevent its good and fair (PASER 10-5) roads from becoming poor (PASER 4-1)
  - Move 2% of the road network out of the poor category



# Planned Projects: 2022-2024

- 23 miles of planned road projects
  - Major road = 7 miles
  - Local road = 16 miles
- Over 60 miles crack sealing preventative maintenance (not shown on map)

# Summary

- City of Rochester Hills will update and submit a transportation asset management plan every three (3) years
- The city is on track to meet its 2024 goal with the current planned projects and funding
  - ► Move 3% of major roads out of the poor category
  - ► Move 2% of local roads out of the poor category
  - Perform capital preventative maintenance (crack sealing) on roads to prevent good and fair roads from becoming poor
