**SUBJECT:** Natural Features Stewardship Program Services

### REQUEST:

City Council is requested to authorize an increase to the blanket purchase order/contract to Niswander Environmental, LLC, Brighton, Michigan for Natural Features Stewardship Program Consulting Services for Green Space in the amount of \$57,000.00 for a new not-to-exceed amount of \$527,000.00 through December 31, 2019.

#### **REASON FOR PURCHASE:**

An increase to the blanket purchase order is needed to align the blanket amount with the approved budgeted amounts to be spent for stewardship projects through December 31, 2019.

The initial blanket for Natural Features Stewardship was approved in December 2017 only included activities on the City's Green Space properties, budgeted in the Green Space Fund. In the 2018 & 2019 Budgets, funds were also budgeted in the Parks – Natural Resources Division (NRD) cost center in the General Fund for Natural Features Stewardship activities on City-owned properties which were non-Green Space properties. The City's non-Green Space stewardship activities in 2018-2019 were not included in the initial blanket amount.
