AN ORDINANCE TO AMEND CHAPTER 138, ZONING, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO REZONE TWO PARCELS OF LAND TOTALING APPROXIMATELY 1.06 ACRES, KNOWN AS PARCEL NOS. 15-35-352-019 AND 15-35-352-067 LOCATED at 3841 S. ROCHESTER ROAD AND VACANT PARCEL IMMEDIATELY TO THE NORTH, SOUTH OF M-59 FROM B-5 (AUTOMOTIVE BUSINESS) TO B-2 (GENERAL BUSINESS) AND TO PRESCRIBE PENALTIES FOR THE VIOLATION THEREOF.

THE CITY OF ROCHESTER HILLS ORDAINS:

Section 1. The zoning classification of the following described property shall be amended as follows:

- **Section 4.** Penalty. All violations of this ordinance shall be municipal civil infractions and upon a determination of responsibility therefor shall be

punishable by a civil fine of not more than \$500.
