REQUEST:

City Council is requested to approve a blanket purchase order/contract for construction engineering services for the proposed 2020 HMA Road & Pathway Rehabilitation Program in the amount of \$190,400.00 to Anderson, Eckstein and Westrick, Inc. of Shelby Twp., Michigan and authorizes the Mayor to execute the contract on behalf of the City.

REASON FOR PURCHASE:

The Department of Public Services recently received bids for the 2020 Road & Pathway Rehabilitation Program. Based on the 2020 department workload, the Department of Public Services has determined an engineering consultant should supplement the construction engineering services.

Staff recommends AEW to provide the construction engineering services to the City. The attached proposal describes the scope of services included for the construction engineering services to complete the work.
