SUBJECT: Geotechnical Engineering/Materials Testing Services, City File E17-008

REQUEST:

City Council is requested to authorize a blanket purchase order and contract for geotechnical engineering and materials testing services to Testing Engineers and Consultants, Inc., Troy, Michigan in the amount not to exceed \$678,100.00 through December 31, 2019.

REASON FOR PURCHASE:

In 2014, The City solicited Request for Proposals for these services with three (3) proposal responses received. An evaluation committee consisting of staff from the Department of Public Services and Purchasing reviewed and evaluated the proposals. Testing Engineers and Consultants (TEC), Inc., was selected as providing the best value to the City based on experience and qualifications, capacity to do the work, single point resources and competitive cost proposal. The contract term called for a three (3) year initial contract period, with the option to renew for two (2) one-year (1) additional periods provided the City was satisfied with the services received and all terms and conditions remained firm. The City has been satisfied with services and is recommending a one (1) year extension of the contract.

Geotechnical engineering is utilized by the Department of Public Services for public works projects and materials testing services on both public and private development projects. Additionally, the Building/Facilities Department utilizes materials testing services on City construction projects. It is anticipated that the geotechnical and material testing services contract will be utilized for Innovation Hills as well.
