SUBJECT:	Fire Suppression and Fire Alarm Plan Review and Inspection Services for 2016 and 2017

REQUEST:

City Council is requested to authorize a contract/blanket purchase order to Fire Safety Consultants, Inc., Elgin Illinois, as primary vendor, and Fire Savvy Consultants and Services, L.L.C., Commerce, Michigan, as secondary vendor, for fire suppression and fire alarm plan review and inspection services in the amount not-to-exceed \$200,000.00 through December 31, 2017.

REASON FOR PURCHASE:

The City of Rochester Hills solicited proposals from qualified and experienced firms to assist the Building Department with fire suppression plan review and inspection services for commercial and industrial projects in accordance with the State of Michigan Construction Codes. The plan review and inspection fees are reimbursed to the City by commercial and industrial developers.

Proposals were reviewed by a Building Department evaluation team, who selected Fire Safety Consultants to perform the required services based on qualifications and experience of staff proposed to work on the City's projects and as providing best value for the City. Fire Savvy Consultants and Services, L.L.C., Commerce, Michigan was selected as secondary vendor, for back-up services. The number of plan reviews required has increased significantly in the past year and it is expected that the workload will continue over the next year; therefore a secondary vendor is needed in case the primary vendor is not able to handle the workload.

The increase above the current budgeted amount for 2016 and 2017 is due to additional services needed for fire alarm plan review and inspections caused by the departure of our electrical inspector who previously performed these duties. The newly hired electrical inspector is in the 2 to 3 year process of obtaining the necessary training and certifications to perform this work.

Please note that this is a pass through cost that is paid for by the fire suppression or fire alarm contractor receiving the services.

As well FY 2017 Projected figures will be updated as well.
