**SUBJECT:** Wireless Cellular Service

#### **REOUEST:**

City Council is requested to authorize a blanket purchase order to Verizon Wireless, Basking Ridge, New Jersey for wireless cellular services in the amount not-to-exceed \$151,000.00 through June 30, 2022.

### **REASON FOR PURCHASE:**

The City uses the service of Verizon Wireless as the wireless service provider for cellular phones and mobile data devices through the National Association of State Procurement Officials ValuePoint (NASPO) Cooperative Purchasing Program. The State of Nevada competitively bid and awarded a contract for wireless services to Verizon Wireless. To determine pricing was the lowest available to the City, other cooperative contracts were reviewed and evaluated, including the State of Michigan MiDeal contract with Verizon. The best value pricing available to the City for cellular services is through the NASPO contract and it is recommended the City continue utilizing this contract for these services. Award is recommended to Verizon Wireless, Basking Ridge, New Jersey utilizing the NASPO contract.
