Woodland Boardwalk Trail Development Proposal for Engineering Services

Hubbell, Roth & Clark, Inc. (HRC) is pleased to offer engineering services to the City of Rochester Hills for the subject project. We propose that all items of work be completed under the terms and conditions of our existing Agreement for Professional Engineering Services.

The proposed Woodland Boardwalk Trail development is part of a network of trails being developed within Innovation Hills. It is located with an area that may impact some wetlands requiring a Michigan Department of Environmental Quality (MDEQ) permit. A breakdown of our proposed services and budgeted hours are summarized below and in the following table:

1. <u>Survey</u> – under this task HRC will survey the trail and perform tree tagging as noted. The tree tagging is based on a \$15 per tree and costs were estimated based on aerials and previous site visits.

Estimated Hours = 112

2. **Permits** – under this task HRC will prepare and submit the permit required from the MDEQ for proposed work in wetlands and/or the floodplain. Included in this effort is pre-application meeting with MDEQ and City staff as necessary.

Estimated Hours = 16

3. <u>Plans and Specifications</u> – under this task HRC will complete technical specifications for the Woodland Boardwalk trail. To comply with the City's grant requirements, the trail will be designed to meet Universal Design guidelines.

Estimated Hours = 120

4. **Project Coordination** – under this task HRC will assist the City with contractor and grant questions throughout the design and bid process. Meetings and monthly progress reports are included, as needed.

Estimated Hours = 15
