AN ORDINANCE TO AMEND SECTION 79-7, FEES OF CHAPTER 79, SPECIAL EVENTS, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO MODIFY FEES CHARGED FOR APPLICATIONS, PLAN REVIEWS AND PERMITS, AND TO REPEAL CONFLICTING ORDINANCES.

THE CITY OF ROCHESTER HILLS ORDAINS:

<u>Section 1</u>. Section 79-7 of Chapter 79 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 79-7. Fees.

Application, plan review, permit and inspection fees for tenant and building owners shall be charged as follows:

- (1) Application fee.....\$100.00

Application, plan review and, permit and inspection fees for all others shall be charged as follows:

- (3) Permit fee:
 - a. 1—10 days150170.00
 - b. 11—20 days225255.00
 - c. 21—30 days300340.00

<u>Section 2</u>. <u>Severability</u>. This ordinance and each article, section, subsection, paragraph, subparagraph, part, provision, sentence, word and portion thereof are hereby declared to be severable, and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this ordinance shall not be affected thereby.
