Tom Kalas Profile

Tom Kalas received his JD/Law Degree from the University of Detroit-Mercy School of Law in May 1988. He became a licensed attorney in the state of Michigan in November 1988. He has extensive real estate and commercial transaction and litigation experience and, since January 2002, has served as the principal attorney for his law firm with an emphasis on complex civil litigation, zoning and land use, real estate and business matters, and transactions.
