SUBJECT: Purchase Authorization for Tractor with Backhoe and Trencher

REQUEST:

City Council is requested to amend authorization of the purchase of a tractor with backhoe and trencher utilizing the State of Michigan MiDEAL Extended Purchasing Program from Rochester Lawn Equipment, Rochester Hills, MI to Deere & Company, Cary, NC in the amount of \$52,859.35.

REASON FOR PURCHASE:

The authorization of a purchase order to Rochester Lawn Equipment was approved at the October 7, 2019 Council meeting. The City will receive delivery of the equipment through Rochester Lawn Equipment. Payment, however, is made directly to Deere & Company requiring the purchase order to be issued to Deere & Company. As such, City Council is requested to amend the purchase order authorization from Rochester Lawn Equipment to Deere & Company, Cary, NC.

The City purchases John Deere equipment through the State of Michigan MiDEAL Extended Purchasing Program, as it is the best pricing that can be offered to local units of government for John Deere Equipment. Equipment purchased through this program is at a cost significantly lower than retail. The discount received by utilizing the State of Michigan contract for the tractor, backhoe and trencher is 16%.

The Parks & Natural Resources department will use the tractor and attachments for general grounds maintenance and construction projects that need to be completed throughout the parks and museum.
