RE: **TCO PK-84.1 Nawakwa – Sec 34**

In March of 2005, the Department of Public Service received complaints from residents regarding overflow parking onto Nawakwa due to the newly established C.J. Mahoney's Pub. Staff reviewed the parking situation and recommended issuing the following TCO at the April 12, 2005 Advisory Traffic and Safety Board (ATSB) meeting (copy of Traffic Study Summary attached). Abutting property owners were notified of the ATSB meeting agenda.

**TCO PK-84.1** "No Parking between the hours of **7:00 pm and 2:00 am Thursday through Saturday** within the right-of-way of both sides of Nawakwa from Shadywood to Rochester"

**TCO PK-84.2** "No Parking between the hours of **7:00 pm and 2:00 am Thursday through Saturday** within the right-of-way of both sides of Hickory Lawn from Rochester to a point four hundred (430) feet westerly thereof"

The ATSB opened the meeting for public comment (copy of ATSB meeting minutes attached). Several residents commented on the proposed "**No Parking**" zone and requested that the TCO be revised to restrict the parking from **5:00 pm to 2:00 am Thursday through Saturday**.

After the public comment was closed, the ATSB discussed alternate time restrictions. A motion was made to revise the "**No Parking**" restriction to "**Anytime**". This motion **failed** two (2) to four (4).

After further discussion, the ATSB made another motion to revise the TCO to restrict parking, **between the hours of 5:00 pm and 2:00 am** 7 days week. The revision to the TCO was recommended in an effort to cover holidays, special events, and other promotional events that may occur during the week. This motion **passed** six (6) to zero (0).

Staff concurred with the boards recommended revision and issued the following revised TCO on April 18, 2005 (copy attached):

**TCO PK-84.1** "No Parking between the hours of **5:00 pm and 2:00 am** within the right-of-way of both sides of Nawakwa from Shadywood to Rochester"

**TCO PK-84.2** "No Parking between the hours of **5:00 pm and 2:00 am** within the right-of-way of both sides of Hickory Lawn from Rochester to a point four hundred (430) feet westerly thereof"
