## "Statement Indicating Why Zoning Change is Requested"

I am the owner and operator of the existing BP gas station, located at 3841 Rochester Road, Rochester Hills, Michigan.

I have owned and operated this gas station since May 12, 2005.

This location is a "converted" two service bay location from at least 25 years ago, probably longer. What that means is the original purpose of this gas station was to sell gasoline AND perform auto/truck repairs in the service bays. At some point, Amoco Oil decided to close the service bays, and "make" a miniature convenience store, which is how the station is operated today.

In order to be competitive with today's gas station-convenience stores, a building containing approximately 4400 square feet (current building is 1200 square feet) is standard, which will contain as many as 25 cooler doors (currently location has 9), and sell Beer/Wine and alcohol (current location sells zero alcoholic beverages).

The exterior pump islands need to be spread out with a "dive in" concept. Existing parallel islands are too tight, and do not allow a traffic flow conducive to a high volume gas station.

The existing building is old and run down, and needs to be put to rest.

The reason the zoning change is requested is so the owner can demolish existing underperforming gas station, and build a retail center that will serve the needs of the entire Rochester Hills community. Many years ago, the B-5 existing zoning was the proper choice. This area, this community, this interchange has undergone significant changes which now make this location a prime retail shopping center venue, not a run down converted gas station location. B-2 zoning is indicated, and requested.
