*Mayor Barnett noted that Team Falcon #98725B consists of superstar students who have done some amazing things. He commented that the City has a tremendous amount of people earning a living in the field of robotics, and more robots are made in Rochester Hills than in any other city in North America. He stated that Team Falcon has won back-to-back State Championships and will be heading on to the World Championships in Louisville next month. He congratulated the team members for their successful championship, introduced **Austin Helm, Brendan Algate, Ashlyn Helm and Patrick Puscas**; and he read a proclamation honoring the team.*

Team Captain Austin Helm thanked Mayor Barnett and City Council for the recognition. He expressed his appreciation for the support of their church, school and mentor Mr. Hall over the past five years, and thanked God for what He allowed them to accomplish. He stated that the team looks forward to representing the city at the World Competition in April.

Ashlyn Helm presented a box of homemade sugar cookies to Mayor Barnett and Council.

ORDINANCE FOR INTRODUCTION

2018-0113 Acceptance for First Reading - An Ordinance to Add New Section 74-113 to Division 3 of Article II, City Parks, of Chapter 74, Parks and Recreation, of the Code of Ordinances of the City of Rochester Hills, Oakland County, Michigan, to prohibit smoking in Thelma G. Spencer Park, to repeal conflicting or inconsistent Ordinances, and to prescribe a penalty for violations

Ken Elwert, Parks and Natural Resources Director, stated that this proposed Amendment will implement a no-smoking ordinance for Spencer Park as a trial. He explained that smoking at Spencer Park conflicts with the park's large user base and causes operational, health, safety, and welfare issues resulting from the close gatherings that the park hosts and children who do not wear shoes while there. He pointed out that the Ordinance would prohibit e-cigarettes and hookahs as well, and prohibit any device that emits smoke in one way or another. He mentioned that the Department has been communicating with potential users for the last four months to let them know that this ordinance was a possibility.

He stated that the Mayor's office conducted research and found over 100 communities in Michigan that have passed some sort of beach, playground or park tobacco-free rule. He stated that many communities have a system-wide ban. He noted that as of 2016, about 1,200 communities nation-wide have similar bans.

Vice President Morita stated that she is glad to see this Amendment come forward and questioned whether it might be considered for other parks such as Innovation Hills.

Mr. Elwert responded that this is an opportunity for a trial at the City's most challenging park. Should Council and the Mayor wish to move forward to include other parks, it could be done.

Dr. Bowyer questioned whether a designated smoking area is available at other parks.

Mr. Elwert responded that there is currently no designated smoking area at any park.

He explained that the Museum has a designated smoking area away from the barns and historic structures.

Dr. Bowyer commented that she is not a fan of bans across-the-board, and would prefer to see a restricted area. She noted that her employer Henry Ford Hospital, backtracked a complete ban it had instituted, as it was hard to enforce and resulted in littering at neighborhood properties as smokers stepped off the property onto the right-of-way. She questioned whether the ban could deter bookings for picnics, and what response is anticipated.

Mr. Elwert responded that while a few individuals notified of the possible ban said that they would not schedule picnics if it is adopted, most expressed support of the ban. He explained that no smoking will be allowed in the park. Ample signs will be posted and advance warning will be given to renters.

Mayor Barnett stated that these comments were brought up during discussions over the past weeks and months, and the Administration would like to do the type of experiment that Henry Ford undertook. A report would be presented to Council at the end of the year. He noted that neighboring communities have moved in this direction, and he pointed out that there are no longer designated smoking areas in restaurants. He commented that if challenges are encountered, the Administration would return to Council to report them.

Ms. McCardell questioned whether the majority of park attendees are residents or non-residents.

Mr. Elwert responded that the majority of summer visitors are non-residents; while during other seasons they are residents.

Ms. McCardell questioned whether the ban might attract more residents and how long the trial period would be.

Mr. Elwert responded that the situation would be re-analyzed at the end of the year.

Ms. McCardell noted that vaping is included.

Mr. Elwert stated that he would credit Mr. Staran for that inclusion, as the amendment was a team effort.

President Tisdell concurred with Dr. Bowyer, noting that he is not a big fan of prohibition. He noted, however, that there is rationale to include anything that does burn; and he commented that too many smokers use the world as their ashtray. He commented that he believes that this is worth a try.

PUBLIC COMMENT for Items not on the Agenda

Lee Zendel, 1575 Dutton Road, stated that subsequent to the last meeting where Council received a presentation from SMART regarding transit, Wayne County Executive Warren Evans unveiled a new rapid transit plan which called for 1.5 mills for the next 20 years. Mr. Zendel stated that he asked Mr. Cramer from SMART roughly what percentage of revenue is achieved at the fare box. Mr. Cramer's response was that it was roughly eight to 18 percent. He stated that he is not in support of the request.

Judy Dignam, 1601 Stonecrest Drive, requested Council consider forming a study group to look into transit for the city. She stated that the city's roads are too crowded and pointed out that proposed new developments include two four-story hotels.

Margaret Huggard, 3286 Aquinas Drive, stated that she has watched the City grow and stated that the city should have different ways of looking at transit. She pointed out that Oakland University students come from all over the world and are surprised to learn there is no public transportation. She stated that she would support the idea of a study group and would like to have a SMART millage on the ballot in 2018.

LEGISLATIVE & ADMINISTRATIVE COMMENTS

Responding to Public Comment on public transportation, **President Tisdell** stated that this area was designed for suburban living, and subdivisions were designed to discourage pedestrian traffic. He commented that the City could be looking at a \$3.3 million tax for a half-million dollar need, and would be trying to retrofit a community specifically designed to thwart pedestrian traffic to accommodate a front-door technology. He mentioned that the Public Safety and Infrastructure Technical Review Committee (PSITRC) would be taking up the topic as one of their agenda items. He stated that he rode with Mr. Struzik, the resident who spoke at the last meeting, down to Detroit on the Park and Ride Service from Troy last week; and he noted that about a dozen people used the service from the Troy location to Campus Martius. He pointed out that on the way back, only three people rode to that location. He commented that as of right now, the demand is not there.

Vice President Morita stated that Council has been looking at the issue of public transportation along with many other municipalities in the state. She mentioned that some municipalities are going to a subsidized Uber which is more cost-effective. She commented that many of the city's households are aging in place; and she stated that she cannot imagine residents trying to walk up a hilly street. She stated that the city will need a system that is individualized to the community, and she has faith that the PSITRC will think outside the box and come back with recommendations.

Dr. Bowyer stated that she is a proponent of mass transit; however, she does not want to spend \$3 million for empty buses. She commented that Uber and Lyft work great.

She reported that she, Clerk Barton, and TTI Global CEO Lori Blaker attended the Women of Tomorrow Detroit Dinner on March 22, 2018 at the Detroit Athletic Club. She mentioned that Ms. Blaker has won the Oslo Peace Award.

Mr. Deel stated that he receives many emails discussing projects going on in the city, and he encouraged residents to visit the City's website to learn of ways they can provide feedback on the 2018 Master Plan.

He announced that the Rochester-Avon Recreation Authority will hold a Spring Break Camp during the week of April 2 through 6. He reported that their Easter Egg Hunt was very successful with many children attending.

He noted that the Rochester Hills Public Library will host Ken Daniels, author of "If These Walls Could Talk: Stories from the Detroit Red Wings Ice, Locker Room, and Press Box" on April 24.

Mr. Hetrick responded to Ms. Dignan and Ms. Huggard noting that they will be contacted as the PSITRC begins a transit discussion. He expressed his appreciation to Ms. McCardell for her work on the Youth Dialogue Day. He congratulated the 100-plus recipients of the Avondale Youth Assistance awards.

He noted that the Southeast Michigan Council of Governments (SEMCOG) has a ride-sharing application, Commuter Connection, that allows anyone to find a ride to a location. He invited interested individuals to visit commuterconnectmi.com.

He announced that Mayor Barnett was elected as a Delegate and he was named Alternate to the SEMCOG Executive Committee.

Mr. Kubicina thanked President Tisdell for accepting Mr. Struzik's offer to ride along on his public transit trip. He stated that it shows that Council is open-minded and will check things out for themselves. He noted that everyone should be cheering for the Tigers on Opening Day.

Ms. McCardell commented that she is not surprised that President Tisdell took the initiative to ride to Detroit on public transit, and she noted that she has seen him participate actively on other things.

She announced that her next Java With Jenny session would be held Saturday, April 7, 2018, at 10:00 a.m. at the Avon on the Lake Senior Living Complex.

Mayor Barnett stated that Rochester Hills holds two seats on SEMCOG's Board. He congratulated the women of this Council who attended the Women of Tomorrow event, and he noted that Ms. Blaker won the 2018 Oslo Business for Peace Award, which he commented is equivalent to the Nobel Peace Prize for business.

He stated that public transit is a hot topic and the conversation will be continued. He mentioned that he had lunch with Detroit Mayor Mike Duggan, and public transportation was one of the topics discussed. He noted that Rochester Hills' situation is unique, and stated that public transportation has to make sense for the community. He made the following announcements:

- The City is in need of crossing guards, and interested individuals would earn \$13 per crossing time, typically from 8:00 a.m. to 9:00 a.m. and again at 3:15 p.m. to 4:15 p.m.
- Kidde has announced a massive recall of smoke detectors. While this is not the brand that the Fire Department uses in its Sound the Alarm program, residents are encouraged to check their detectors to see if they have been recalled.
- The Rochester Grangers Old Fashioned Baseball Team is looking for new members. Players need to have a passion for history and basic skills for baseball.
- A significant fire occurred in Auburn Hills two nights ago on Five Points Drive near Oakland University.
- The State of the City Address is set for Wednesday, March 28, 2018 at Stoney Creek High School. Doors will open at 6:30 p.m. and the event will start at 7:00 p.m.

Deborah Barno stated that she was in attendance to represent the Heatherwood Village Homeowners' Association, and requested Council consider a resolution to allow another five years of participation in the nest egg destruction program. She noted that the program has been very effective over the past ten years and pointed out that the subdivision does not undertake a goose roundup.

Mr. Deel mentioned that he owns property in Heatherwood Subdivision. He stated that he does not feel it necessary to disqualify himself from discussion or vote and questioned whether any member of Council had any objections to his participation in this item.

No Council Member expressed any objections.

Mr. Deel stated that the request is typical of the process and noted that the nests are collected around Arlington Pond.

Ms. Barno commented that the Department of Natural Resources requires nest destruction be undertaken before a goose roundup. She pointed out that Heatherwood has never done a roundup.

Mr. Deel mentioned that Goosebusters is the company used for the nest destruction.

Dr. Bowyer questioned whether the program has been effective for the last few years, and why Council is being asked to consider the request.

Ms. Barno responded that the quantity of nests have gone down. She stated that in order to apply, the association must get signatures from 70 percent of the homeowners or receive a resolution from Council. She stated that the previous board members handling this item requested a resolution, and the current board is asking for the same.

Vice President Morita noted that the signatures of 28 homeowners would be required and questioned whether the board has ever attempted to obtain the signatures.

Ms. Barno responded that she has not since she inherited it from another board member. She stressed that the residents surrounding the pond are in favor of the program.

Vice President Morita stated that she has difficulty in approving this item if residents are not willing to sign the petitions. She commented that there are other ways to control geese other than destroying eggs. She pointed out that she did not vote in favor of another similar request that previously came to Council.

President Tisdell stated that he previously lived in suburban Minneapolis, and a roundup of geese only resulted in the geese returning. He added that the roundup activities actually killed more geese.

A motion was made by Bowyer, seconded by Deel, that this matter be Adopted by Resolution. The motion carried by the following vote:

Ken Elwert, Parks and Natural Resources Director, stated that Council is requested to authorize an application for a \$150,000 grant through the Recreation Passport Program. He mentioned that it is a different program than in the past, as funding for this program comes through license plate opt-in fees. He explained that one tennis court will be replaced with four pickleball courts, and four tennis courts will be redone. He added that the project will include some environmentally sensitive items including rainwater collection.

Dr. Bowyer commented that more people are playing pickleball than tennis, and she stated that she is glad that the project is in the Capital Improvement Plan. She noted that rain gardens and recycling areas will help the city stay natural.

Ms. McCardell expressed her appreciation to Mr. Elwert for his work on applying for the grant.
