AMENDMENT TO WATERMAIN EASEMENT

On the fifth day of July, 1990, Hampton Crossing Associates, a Michigan partnership, granted to the City of Rochester Hills, a Michigan municipal corporation "City"), an easement for the construction, operation, maintenance, repair and/or replacement of a water main, ("Water Main") on under, through and across land ("Land") more particularly described in the Watermain Easement recorded by the Oakland County Register of Deeds on July 28, 1994 in Liber 14865 at Page 601.

During construction of improvements to the Land, a section of the Water Main is being built outside of the existing Watermain Easement, and New Plan Hampton Village, LLC, a Delaware limited liability company, whose address is 22054 Farmington Road, Farmington, Michigan 48336, the current owner of the Land and improvements by mesne conveyances, ("Owner") and City desire to relocate Easement A and to amend the description of Easement A to correctly describe its new location

Now, therefore, Owner agrees to and by this Amendment to Watermain Easement does hereby amend Line 4 of the existing Watermain Easement to the legal description set forth herein and as depicted and described on attached Exhibits A and B, which amended description shall replace and supersede the description of Line 4, which shall replace and supersede the legal description of Line 4 of the existing Waterman Easement as originally recorded. The originally recorded legal description of Line 4 of the Watermain Easement shall be of no further force or effect and the City shall have the same easement rights in Line 4 of the Watermain Easement described and shown in the attached Exhibits A and B.

In all other respects, the original Watermain Easement is ratified, confirmed and redeclared. The recording of this Watermain Easement is exempt from Michigan Transfer Taxes under MCLA Sections 207.526 (a) and 207.505 (a).


