SUBJECT: 2018 Medical Marihuana Operation and Oversight Subgrant Agreement

REQUEST:

It is requested that City Council accept grant funding from Oakland County, as received by the State of Michigan, allocated to the City of Rochester Hills under the 2018 Medical Marihuana Operation and Oversight Grant.

REASON FOR PURCHASE:

The Oakland County Narcotic Enforcement Team (NET) is a multi-jurisdictional task force. The mission of NET is to identify, investigate, and prosecute drug traffickers and dismantle their organizations. In January of 2010 the Oakland County Sheriff’s Office Rochester Hills Substation assigned a Deputy to NET. One of the goals of NET is to monitor compliance with the Michigan Medical Marihuana Act (MMMA). NET investigators conduct “knock and talk” investigations on marijuana grow operations. During these investigations patients and caregivers are checked for compliance and educated as needed. NET investigators also investigate Drug Trafficking Organizations that violate the MMMA.

For 2018 Oakland County has received a Medical Marihuana Operation and Oversight Grant from the State of Michigan. If approved by City Council, the City of Rochester Hills will receive a portion of the grant totaling \$5,750. These dollars will be used to offset the overtime costs incurred by the assigned Deputy for Medical Marihuana Investigations.

In 2016 and 2017 Oakland County and the City of Rochester Hills did receive grant dollars from the Medical Marihuana Operation and Oversight Grant. Oakland County Corporation Council recently reviewed this grant and determined that the Subrecipient Agreement between Oakland County and the City of Rochester Hills is now required.

BUDGET:

If accepted, the grant funds will be used in the Special Police Protection Fund to offset overtime costs incurred by the assigned Deputy for Medical Marihuana Investigations.
