Grantor agrees not to build or to convey to others permission to build any permanent structures on the above described easement.

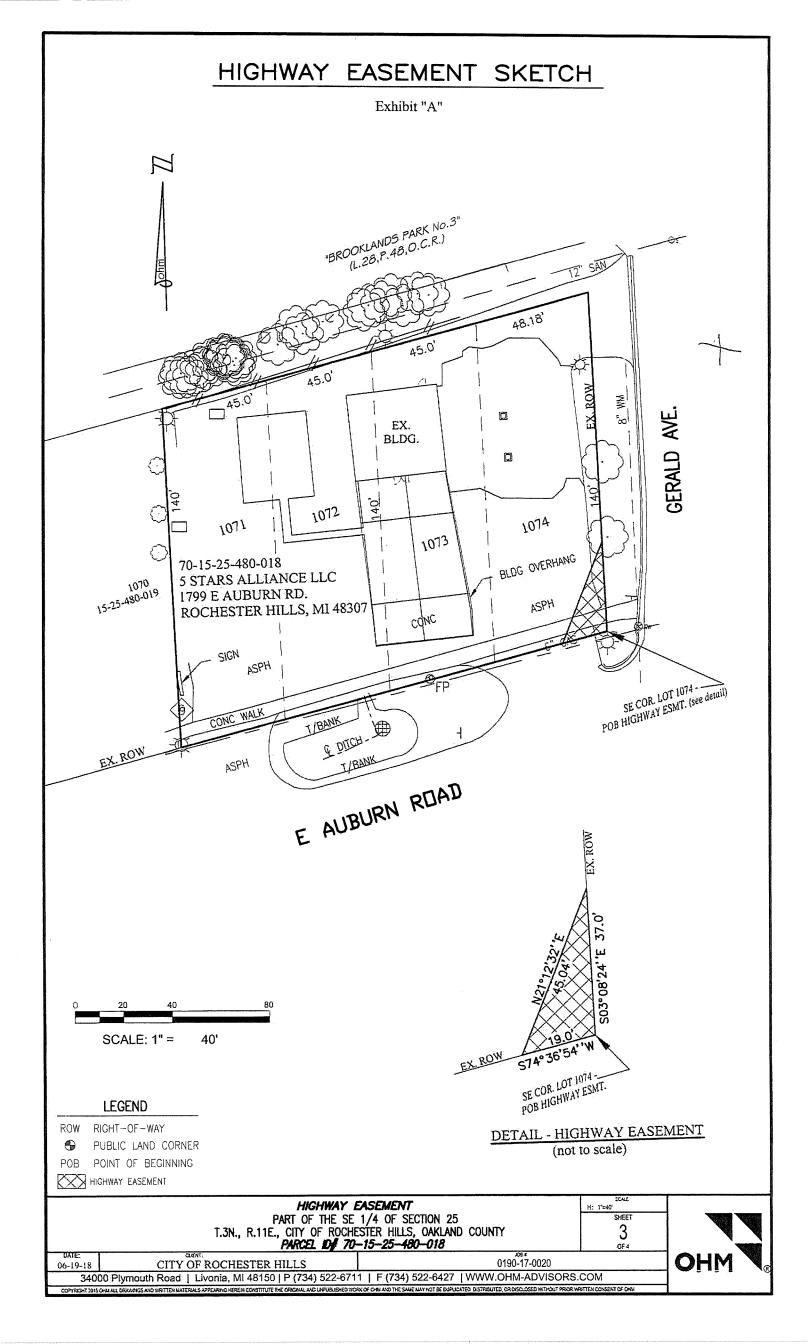
