SUBJECT: JDE Consulting and Support Services

REOUEST:

City Council is requested to authorize an increase to the blanket purchase order for JDE Consulting and Support Services in the amount of \$57,000.00 for a new not-to-exceed amount of \$69,000.00 through May 31, 2020.

REASON FOR PURCHASE:

The City solicited quotes for JDE Consulting and Support Services in 2015 and received two responses. Of the responses received JDEVolution was selected as the lowest, responsive, responsible bidder. JDEvolution has been providing support services to the City over the past three (3) years for smaller projects that include writing of new reports, assisting with system issues during open enrollment process, creating interfaces between systems when new software is purchased etc. The City has been very satisfied with the services received from JDEvolution.

The requested increase to the blanket purchase order is due to a recently vacated position within the Management Information Systems Department leaving a need for JDE support services for city departments. It is expected that JDEvolution will assist the City with as needed consulting and support services over the next two years. The City will be required to upgrade their financial system at some point in 2019 and JDEvolution services will be required to assist the City through that process. At this time, we feel that the requested amount will cover needed services during the contract term, however there may be a need to come back for an increase in the blanket should the upgrade project be more involved than initially anticipated.

JDEvolution is qualified to assist the City with these services. The main project contact is very familiar with the way in which the City operates and understands our system setup extremely well.
