Dear Ms. Barton:

This is La Colina, LLC's application to transfer ownership and location of the Class C Liquor License with Sunday Sales (AM and PM) Permit and Specific Permit (Food) from 221 Royal Oak, LLC, Business Id. No. 240103 (currently in escrow at 323 S Main, Royal Oak, Oakland County, Michigan) to be located at 6830 N Rochester Rd., Rochester Hills, Oakland County, Michigan; request for a new SDM License, new Outdoor Service Area Permit, and new Entertainment Permit; and request to cancel the Specific Permit (Food).

La Colina, LLC is seeking approval from the City of Rochester Hills ("City") to transfer into the City a Class C liquor license from the City of Royal Oak to operate a full service authentic Italian restaurant doing business as La Colina ("La Colina"). La Colina's menu offers a variety of items with steak, fish, chicken, and salads. La Colina will operate in the space currently operating as Silver Spoon. La Colina's hours of operation will be Monday through Saturday from 4:00 p.m. to 10:00 p.m. La Colina may extend their hours based on customer demand.

The entire building is approximately 118,000 square feet. La Colina will be

approximately 2,400 square feet and will have an interior seating capacity of 70 patrons and a small patio area outside.

The members of La Colina, with their capital contribution amounts, are as follows:

- M & A Hospitality Rochester, LLC, 20% (members Stolion Liti and Alba Male, capital contribution \$30,000);
- Monkey 22, LLC, 10% (members Victor Ventimiglia and Karen Griffin, capital contribution \$15,000);
- 444, LLC, 10% (member Cynthia Conklin, capital contribution \$15,000);
- Cito, LLC, 30% (member Blendi Cito, capital contribution \$45,000); and
- Hekuri, LLC, 30% (member Altin Hekuri, capital contribution \$45,000).

The cost of the liquor license and inventory will be \$100,000, which will be financed by the member's capital contributions. La Colina does not expect to do renovations except to clean up and do a little cosmetic facelift.
