SUBJECT: Request for approval of a Conditional Use to construct a drive-through facility at a proposed Genisys Credit Union at the southeast corner of Rochester and Eddington Blvd.

REQUEST:

Approval of a conditional use to construct a credit union with drive-through at the southeast corner of Rochester and Eddington Blvd. The site is zoned R-4 One Family Residential with an FB-2 Flexible Business Overlay and will be developed using the FB standards.

BACKGROUND:

The site will be accessed by Eddington Blvd. The eastern portion of the site will be preserved as a park area for employees and visitors with a meandering sidewalk and benches. Banks with drive-through facilities in the FB district require a conditional use approval from City Council. The standards for Council's consideration regarding drive-through uses are listed in *Section 138-4.410* of the Zoning Ordinance and the findings are listed in the enclosed resolution. The issuance of the conditional use is a discretionary decision by the City Council based on five general criteria contained in *Sec. 138-2.302* of the Zoning Ordinance as follows:

- 1) *Will promote the intent and purpose of this chapter.*
- 2) *Will be designed, constructed, operated, maintained, and managed so as to be compatible, harmonious, and appropriate in appearance with the existing or planned character of the general vicinity, adjacent uses of land, the natural environment, the capacity of public services and facilities affected by the land use and the community as a whole.*
- 3) *Will be served adequately by essential public facilities and services, such as highways, streets, police and fire protection, drainage ways, refuse disposal, or that the persons or agencies responsible for the establishment of the land use or activity shall be able to provide adequately any such service.*
- 4) *Will not be detrimental, hazardous, or disturbing to existing or future neighboring land uses, persons, property, or the public welfare.*
- 5) *Will not create additional requirements at public cost for public facilities and services that will be detrimental to the economic welfare of the community.*

The Planning Commission held a public hearing at its July 16, 2019 meeting to review the requests for a conditional use recommendation, tree removal permit, natural features setback modification and site plan approval. The requests were unanimously passed (one recused) with findings for the conditional use in the attached resolution. Please refer to the meeting minutes for additional details of the discussion.

RECOMMENDATION:

Staff and the Planning Commission recommend that City Council approves the conditional use to construct a drive-through at Genisys Credit Union proposed at Rochester and Eddington Blvd., based on plans dated received by the Planning and Economic Development Department on May 28, 2019.
