STAFF REPORT

Matt Einheuser discussed Niswander's progress. They have spent time at multiple Green Spaces and are having much success with buckthorn management. This includes the work that was completed in Innovation Hills Park. They will be focusing on phragmites in September. Lance DeVoe mentioned installing temporary deer fencing at Ruby. This would allow the prairie

to be established without the deer eating or pulling up everything they try to plant.

Einheuser mentioned that the phragmites program has 14 applicants and most of them will be treating.
