STAFF REPORT

Matt Einheuser said Niswander has been working on Ruby, they planted and fenced the prairie to protect it. They attacked the buckthorn at Harding.

Einheuser worked to develope draft signage for the Green Space Ordinance. He is waiting for the ordinance to be codified to have the correct link on the sign. The signs will be consistent with the other Green Space and park signs. Discussion ensued.

Einheuser, along with a committee, provided recommendation to council for the stewardship contract. Throughout the interview process Cardno had a very structured process and partnership feel. They assist with grant writing, attend city council meetings as needed. Einheuser mentioned they would work on outreaching to surrounding homeowners.
