Subject: Updated Review of Third Reimbursement Request, Legacy Rochester Hills, LRH

Development LLC, Northeast Corner of Hamlin and Adams Roads, Rochester Hills (ASTI

Project No. 9675-21)

As requested by the City of Rochester Hills (the City), ASTI has reviewed all provided documentation regarding the third reimbursement request from LRH Development, LLC (the Developer) for the project located at the northeast corner of Hamlin and Adams Roads. The project includes two parcels, 15-29-101-022 (Parcel A) and 15-29-101-023 (Parcel B), which are considered the Eligible Property. The following documents provided the basis for this review:

- 1. The Brownfield Plan dated April 9, 2018
- 2. The Reimbursement Agreement, dated April 23, 2018
- 3. The Reimbursement Request prepared by AKT Peerless, cover letter dated February 16, 2021 and titled Legacy Rochester Hills, Reimbursement Request #3 for Eligible Activities, and supplemental information provided March 30, 2021 (the Request)

The purpose of this review is to determine if the Request for the Eligible Property is in compliance with the approved Brownfield Plan, the Reimbursement Agreement, 1996 PA 381 (Act 381) at the time of the Brownfield Plan approval, the City's cost reimbursement procedures, and generally accepted practices. The following are specific requirements for a request for reimbursement:

- The Reimbursement Agreement requires that the applicant submit copies of invoices and an itemized statement of costs, including a narrative of work completed.
- The Brownfield Incentives Policy for the City indicates that a reimbursement request include invoices and proof of payment organized by category.

This review includes the attached Table 1, which summarizes the Request by category and Table 2, which summarized amounts recommended for reimbursement to date, and provides the status of each category. Please note that costs were not allocated between Parcel A and Parcel B in the Request, so a comparison to tasks listed in the Brownfield Plan was not possible.

Background

The Eligible Property is the subject of a Brownfield Plan approved on April 23, 2018 (the Plan), a Reimbursement Agreement approved April 23, 2018, and a 381 Work Plan dated June 14, 2018. The Plan estimates that eligible costs with contingency to be \$9,619,587, and that interest is estimated at an additional \$3,800,000, for a total estimated not-to-exceed reimbursement of \$13,419,587. estimates that tax increment capture will continue for 21 years, but will not exceed 24 years.

Reimbursement Request


This is the third reimbursement request for this project. This Request was for \$2,202,661.68 for eligible activities as described in the supporting documents and does not include a request for interest payment. The Request was supplemented by an email dated March 30, 2021 from Sam Seimer of AKT Peerless.

This review is based on a total requested amount of \$2,202,672.28, due to the following minor differences as indicated below and in Table 1.

- Reference Line 159: HM Invoice No. 26002 was listed in the Request for \$111,842.94 but was actually for \$111,842.98, for a difference of \$0.01.
- Reference Line 166: HM Invoice No. 26766 was listed in the Request for \$76,888.65 but was actually for \$79,897.26, for a difference of \$8.61.
- Reference Line 168: HM Invoice No. 27130 was listed in the Request for \$95,667.97 but was actually for \$95,669.97, for a difference of \$2.00.

The Request included a summary table, copies of invoices being requested for reimbursement, waivers of lien, cancelled checks, and an Accounts Receivable Ledger from AKT Peerless. A detailed narrative was not provided. Based on the Request, additional explanations were provided by AKT Peerless for the following items:

- 1. Reference Line 161: HM Invoice 26063 lists work as being conducted on "Neighbor's Property". The supplemental information confirmed that the work was limited to the Subject Property, in the area were encroachment had occurred from adjacent property owners.
- 2. Reference Lines 161 to 163 for Installation of Hydraulic Barrier: HM Invoices 26063, 26128, and 26157 refer to "Managing Hill on City of Rochester Hills Property" in the amount of \$35,000. The supplemental information indicated that these services were for moving soils within the easement for the City park property to provide access for the initial attempt at installation of the slurry wall. This access area will now be used for the installation of the modified slurry wall using a different technique (refer to the Amended 381 Work Plan). This activity is indicated to be 100% complete on Invoice 26157.
- 3. Reference Lines 164 to 165 for Installation of Hydraulic Barrier: HM Invoices 26425, 26573, and 26766 indicate that services were completed for "Cut-Off Wall Installation" in the amount of \$56,117.94. The supplemental information indicated that these services were for the initial attempt at installation of the slurry wall using one-pass method. The slurry wall was not installed, and an alternative method of installation is proposed (refer to the Amended 381 Work Plan).

- 4. Reference Line 165: HM Invoice 26573 indicates that services were completed for "Install 2-6" Diameter Landfill Gas Vent with Faux Rocks" at the amount of \$2,500. In addition, a note on the invoice indicates that this is for "Installation of Liner and Cap over former landfill". supplemental information indicated that this was limited to costs of materials which are being stored at the property and did not include installation. This cost was removed by the Developer and will be resubmitted when installation is completed.
- 5. Reference Line 166: HM Invoice 26766 indicates that services were completed for "Cap Installation using Bentonite mats" at the amount of \$32,520.15. In addition, a note on the invoice indicates that this is for "Install Cap". The supplemental information indicated that this was limited to costs of materials which are being stored at the property and did not include installation. This cost was removed by the Developer and will be resubmitted when installation is completed.

Conclusion


As with the previous requests for reimbursement, this Request is for LRH Development, LLC (identified in the Reimbursement Agreement), however, the documents provided indicate that some of the expenses were paid by the Goldberg Companies, or Goldberg (identified in the Plan). Any issues related to the eligible taxpayer should be referred to the City's legal counsel.

Based on the documents provided, the items that have been recommended for approval for reimbursement in the Request are in compliance with the approved Brownfield Plan, the Reimbursement Agreement, 1996 PA 381 (Act 381) at the time of the Brownfield Plan approval, the City's cost reimbursement procedures, and generally accepted practices. In addition, the total amount requested to date is within the approved not-to-exceed amount.

ASTI recommends approval of \$2,163,850.88 as indicated in Table 1. A summary of the recommendation is provided below.

Table 2 summarizes the requests for reimbursement to date in comparison to the expenses recommended for approval. Please note that some line items are over budget, which was not a consideration in recommending approval for reimbursement, because the contingency has not yet been required. The Developer has prepared an Amended Act 381 Work Plan that explains changes to line item budgets. The RHBRA has the authority to approve expenses in amounts that vary from the task amounts listed in the Brownfield Plan, up to the maximum approved.

To date, including this memo, recommendations for reimbursement have totaled \$6,486,667.73 or 77% of the budget for eligible activities, and 67% of the budget including contingency. The remaining available amount, not including interest is \$3,132,919.27.
