SUBJECT: JDE System Consulting and Support Services

REQUEST:

City Council is requested to authorize a blanket purchase order/contract for JDE System Consulting and Support Services to JDEdge Inc., Pompano Beach, FL in the amount not-to-exceed \$215,000.00 for a three (3) year term to expire October 31, 2024 with an option to renew for an additional two (2) year term.

REASON FOR PURCHASE:

The City issued a Request for Proposals to seek the services of a firm who could assist the City on an asneeded basis with its financial system to help troubleshoot issues that may be occurring, programming for reports that may be needed due to new reporting requirements, adjustment to the system based on changes made in City processes, an extension of City staff to act as a liaison between the City and their managed services provider Denovo.

Proposal responses were evaluated by a committee consisting of staff from Accounting, Finance, Human Resources, MIS and Purchasing. Based on the responses, the committee all unanimously supports the recommendation of JDEdge Inc., for award of this contract. The committee feels that this firm is the most qualified to assist the City with their needs based on their overall understanding of the City's needs, familiarity with the City's setup and use of JDEdwards in their operations, as well as their best value cost proposal.
