<u>Section 1</u>. Section 79-7 of Chapter 79 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 79-7. Fees.

Application, plan review, permit and inspection fees for tenant and building owners shall be charged as follows:

- (5) After-hours inspection fees will be charged for building department and fire department inspections at an overtime or double-time rate, as appropriate, with a four-hour minimum.
- (6) If special event permit is cancelled, all fees shall be refunded except the application fee, 25 percent of the permit fee, \$85.00 per inspection, and plan review fees. However, if a special

event permit expires due to 180 days of inactivity there will be no refund of any fees.

<u>Section 2</u>. <u>Severability</u>. This ordinance and each article, section, subsection, paragraph, subparagraph, part, provision, sentence, word and portion thereof are hereby declared to be severable, and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this ordinance shall not be affected thereby

<u>Section 3</u>. <u>Penalty</u>. Except as otherwise provided therein, all violations of this ordinance shall be municipal civil infractions and upon a determination of responsibility therefore shall be punishable by a civil fine of \$500.
