**Whereas**, Traffic Control Order No. TM-35.1 has been issued by the City Engineer in accordance within the provisions of Chapter VI of Act No. 300, Public Acts of Michigan of 1949, as amended (Michigan Vehicle Code), and under the provisions of the City of Rochester Hills Code of Ordinances, Chapter 98 (Rochester Hills Traffic Code) as amended; and

**Whereas**, Said Traffic Control Order covers:

**The Intersection of John R and Auburn Road-Section #25**

**TM-35.1 NO TURN ON RED from northbound and southbound John R onto Auburn Road at their intersection between the hours of 6:30 AM to 9:00 AM and 2:30 PM to 4:00 PM, School Days Only**

**Whereas**, Said Traffic Control Order will not be effective after the expiration of ninety (90) days from the date of issuance, except upon approval by this Council; and

**Whereas**, the Advisory Traffic and Safety Board has considered the issues pertaining to the Traffic Control Order and recommends that the Order be approved;

**Resolved**, that the Rochester Hills City Council approves the issuance of the Traffic Control Order TM-35.1 to be in effect until rescinded or superseded by subsequent orders; and

**Now, Therefore, Be It Resolved**, that a certified copy of this Resolution is filed together with the Traffic Control Order, with the City Clerk of Rochester Hills, Oakland County, Michigan.
