TM-38.19.1 NO LEFT TURN from northbound Brewster Rd onto westbound Shenandoah Dr at their intersection from 6:30 AM to 7:30 AM - School Days Only (Except Buses).

TM-38.19.2 NO RIGHT TURN from southbound Brewster Rd onto westbound Shenandoah Dr at their intersection from 6:30 AM to 7:30 AM -School Days Only (Except Buses).

TM-38.19.3 NO LEFT TURN from northbound Brewster Rd onto westbound Roseview Dr at their intersection

from 6:30 AM to 7:30 AM - School Days Only (Except Buses).

TM-38.19.4 NO RIGHT TURN from southbound Brewster Rd onto westbound Roseview Dr at their intersection from 6:30 AM to 7:30 AM - School Days Only (Except Buses).

**Whereas**, said Traffic Control Order will not be effective after the expiration of ninety (90) days from the date of issuance, except upon approval by this Council; and

**Whereas**, the Advisory Traffic and Safety Board has considered the issues pertaining to the Traffic Control Order and recommends that the Order be approved;

**Resolved**, that the Rochester Hills City Council approves the issuance of the Traffic Control Order TM-38-19 to be in effect until rescinded or superseded by subsequent orders; and
