## **CALL TO ORDER**

Chairperson Windscheif called the Green Space Advisory Board meeting to order at 7:01 p.m.

## APPROVAL OF MINUTES

None were presented.

## COMMUNICATIONS

Chairperson Windscheif reported a communication from Mr. Bob Johns, representing the Cloverport property. Mr. Johns reconfirmed his strong desire to re-open discussions with City Administration regarding the acquisition of the Cloverport property with Green Space Millage funds. Chairperson Windscheif will contact Mayor Bryan Barnett to follow-up.

## PUBLIC COMMENT

Chairperson Windscheif introduced Mr. Richard Schoenherr and Mr. Jesse Kranz, officers with Elro Corporation. They are the developers of Clear Creek Subdivisions, No. 1, 2, 3, 4, and 5. They recently nominated a 50 acre parcel within Clear Creek No. 5. for acquisition by Green Space Millage funds.

Mr. Schoenherr described the parcel as a natural open space, having approximately 2000 trees, 16 acres of wetlands and a stream. The parcel could be developed into approximately 50 residential sites. The primary motivation for the nomination is to determine whether the City has an interest in the parcel. Participation in matching grants was briefly discussed.

Mr. Mike Hartner, Director of Parks & Forestry explained the initial scoring and property maps that were distributed to GSAB members prior to the meeting. The landowners have given permission for GSAB members to walk the property. Discussion followed regarding the parcel's infrastructure and wetland designations.

Chairperson Windscheif relayed appreciation for the nomination. He recapped the evaluation process after which GSAB will determine whether to recommend acquisition to City Council. It is an open process and all are invited to participate.

Chairperson Windscheif acknowledged that Ms. Alice Benbow, Rochester Hills resident, joined the meeting at 7:20 p.m. Member Leo Oriet entered at 7:25 p.m.

Chairperson Windscheif welcomed new GSAB members Laura Douglas and Linda Raschke.

Member McGoldrick reported on the January 2009 Natural Area Advisory Group meeting. Representatives attended from the DNR and various parks departments. A major focus was on value that parks, trails and open space add to communities especially in a down economy. Ms. McGoldrick also distributed information regarding grants.

Mr. Gauthier distributed a revised presentation for the Yates north section parcel nomination that included changes from the last discussion. Chairperson Windscheif recapped, for new members, the progress regarding the north Yates property that has been nominated, reviewed and scored.

The consensus was for members to email comments regarding the presentation to Mr. Gauthier by February 6th. Members Gauthier, Windscheif and Funk will finalize the presentation with a goal of appearing before City Council at a March meeting.

## 2008-0133 GSAB Stewardship & Advocacy Sub-Committee

Member Carvey distributed a revised Stewardship presentation which was reviewed at length. The discussion included:

- \* A draft resolution recommending that City Council sanction a stewardship program. The plan can be the framework explaining what a stewardship program should be with the details worked out later.
- \* The costs of a stewardship program may be two-fold: one cost is to develop a plan and one cost is to implement a plan annually with sustainable funding.
- \* The original City Council resolution establishing GSAB referred to 'maintaining' green space.

It was suggested that the City's web page could contain a list of community service opportunities for volunteers who could choose stewardship activities which would help to contain costs and provide students a means to meet required community service hours.

The consensus was the Stewardship presentation would take priority with a goal of moving it forward to City Council in late February to gain publicity from the new citywide recycling program being launched in April. The recycle program includes a non-profit fund for Green Space Stewardship whereby points can be donated and transferred to dollars to be used for a Stewardship program. The sub-committee was commended for a job well done.
