PUBLIC COMMENT

Mr. Lee Zendel, 1575 Dutton Road, compared the amount of money spent on the City of Warren's new City Hall--\$50 million--to the \$12 million spent for Rochester Hills' new and renovated City Hall. He noted that the contrast is evidence that the City is spending tax dollars responsibly.

LEGISLATIVE & ADMINISTRATIVE COMMENTS

President Rosen noted that there would likely be a vacancy on the Historic District Commission and residents interested in serving should visit the City's website or contact the Clerk's Department for more information.

Mr. Ambrozaitis assured residents that the efforts of Council and the administration to revise the City's blight ordinance are not intended to be punitive or to create greater bureaucracy.

Mr. Hooper reminded residents to vote in the upcoming General Election and reminded them that the Pathway Millage ballot proposal, if passed, would not increase City taxes.

Ms. Raschke asked the City Attorney to discuss a recently passed House Bill that would remove 25 mph speed limits from local rural roads.

Mayor Barnett noted that the City was expecting a good voter turnout for the General Election and encouraged residents to be informed voters. He then welcomed Fresh Market to the City, noting the new grocery store would bring 105 new jobs. He then read a letter from residents who had received assistance through the City's CDBG program, praising the efforts of Financial Analyst **Leon Luedeman** on their behalf.

ATTORNEY MATTERS

City Attorney John Staran described the House Bill Ms. Raschke referred to earlier noting that it primarily impacts "traditional country roads" and there is a formula for determining whether reduced speed limits are warranted based on location and access points. He indicated that the House Bill is in compliance with the Michigan Vehicle Code.

Mr. Scott Cope, Director of Building/Ordinance Enforcement, briefly discussed the efforts of his department to revise and improve the City's response to property maintenance issues, noting the following:

- The blight issue is referenced and addressed in a "scattered" manner throughout the City's ordinances.
- A comprehensive blight ordinance will provide consolidation.
- Blight ordinances from many other communities have been reviewed during this process.
- Provisions of a new State law allow civil fines up to \$2,500.
- A community in Texas has a unique approach to the issue employing a "performance-based" property maintenance approach.
- A baseline survey of the community will assist in future bench marking efforts.

- A draft of the new ordinance will be reviewed by the City Attorney prior to the end of the year.
- **Mr. Cope** noted that his department was in the process of creating a neighborhood guide to encourage voluntary compliance to City ordinances. He sought input from Council, posing the following questions:
- Should this be a proactive or reactive plan?
- How will the City address issues of residents who simply do not have the financial means to maintain their property?
- **Mr. Ambrozaitis** suggested three other communities with strong blight ordinances to be examined in addition to the others. He urged Mr. Cope to be proactive in his efforts. He stressed that he did not want more money expended on this effort or that persons of lesser means be unduly penalized.
- **Mr. Duistermars** stated that "property ownership is a fundamental American freedom" and he did not want to see any enforcement that would be too intrusive.
- Mr. Cope assured Council the ordinance would be applied in a reasonable manner.
- **Ms. Holder** noted that the City cannot dictate residents' lifestyles. She supported the concept of a neighborhood guide to encourage voluntary compliance, stressing that safety should be the main focus of the City's enforcement.
- **Ms.** Raschke expressed her belief that there is not a serious problem with blight in the City and the ordinance officers are doing their best with their current resources. She questioned who is responsible for maintaining the property when a home is for sale and standing unoccupied.
- **Mr. Cope** explained that the owner, no matter where they are located, is ultimately responsible for the property; the real estate broker cannot be held accountable.

PUBLIC COMMENT:

Ms. Rea Siffring, 971 Dutton, stressed that neighbors should work together to resolve blight issues within their subdivisions rather than relying on the City.

Ms. Melinda Hill, 1481 Mill Race, expressed her hope that any ordinance would show tolerance for the homeowners. She objected to the time and expense of conducting a survey of all properties, noting that these types of issues only represent 1% of complaints to City Hall.

COUNCIL COMMENTS:

Mr. Duistermars questioned whether there is a lot of case law regarding regulating blight.

City Attorney John Staran noted that, while the City has the authority to enact a blight ordinance, they are often subjective in nature. He assured Council that he would assist Mr. Cope and his staff in drafting an ordinance that would be objective and defensible with the least amount of intrusion.

- \$14,000 Public Services / Youth Services (732185) Rochester Area Youth Assistance Provide youth enrichment programs including summer camp and tutoring for approximately 100 youths from low-moderate income families.
- \$10,500 Public Services / Battered & Abused Spouses (730137) HAVEN Provide shelter and counseling services for approximately 150 abused spouses and their children who are residents of the City of Rochester Hills.
- \$3,500 Public Services / Emergency Clothing (730571) Reimburse the administrative costs of one or more non-profit agencies that provide emergency clothing services to approximately 200 low-moderate income residents of the City of Rochester Hills.
- \$3,500 Public Services / Youth Services (732185) Avondale Youth Assistance Provide youth enrichment programs including summer camps and tutoring for approximately 50 youths from low-moderate income families.

Mr. Dan Casey, Manager of Economic Development, explained that the issue before Council was to approve the project plan for the Oakland Steiner School prepared by the Oakland County Economic Development Corporation (EDC) to secure tax exempt variable rate bonds for the purchase of the school. He noted that the EDC Act requires that the local municipality approve such a plan.

A motion was made by Ambrozaitis, seconded by Duistermars, that this matter be Adopted by Resolution.

Whereas, there exists in the County of Oakland the need for programs to alleviate and prevent conditions of unemployment, to assist and retain local industrial and commercial enterprises, and to encourage the location and expansion of such enterprises in order to strengthen and revitalize the County's economy and to provide needed services and facilities to the County, the City of Rochester Hills, and their residents; and

Whereas, the Economic Development Corporations Act, Act No. 338 of the Michigan Public Acts of 1974, as amended (the "Act"), provides a means for the encouragement and assistance of industrial and commercial enterprises in locating, purchasing, constructing, reconstructing, modernizing, improving, maintaining, repairing, furnishing, equipping and expanding in the City and the County; and

Whereas, the Economic Development Corporation of the County of Oakland (the "EDC") has commenced proceedings for the assistance, pursuant to the provisions of the Act and through the issuance of its limited obligation economic development revenue bonds, of the Openings Project (the "Project") which is located in this City; and

Whereas, the EDC has determined that the Project is reasonable and necessary to effectuate the purposes of the Act, that the Project Plan prepared in connection with the Project satisfies all of the requirements of Section 8 of the Act regarding project plans, that the persons who will be active in the management of the Project for at least one (1) year after the projected date of the County Board of Commissioners' approval of the Project Plan will have sufficient ability and experience to manage the Plan properly, that the proposed method of financing the Project is feasible, and the EDC has approved the Project Plan; and

Whereas, before this Project can proceed under the Act, this City Council must approve the Project Plan; and

Whereas, this City Council has reviewed the subject Project Plan and concurs in the determinations of the EDC with respect thereto.

Resolved that in accordance with the Act, this City Council hereby approves the Project Plan, which is on file with the City Clerk.

Be It Further Resolved that the Clerk of this City be and hereby is instructed to communicate this approval of the Project Plan to the Board of Directors of the EDC of Oakland County by delivering to said Board of Directors a certified copy of this resolution.

Mr. Dan Casey, Manager of Economic Development, explained that Rochester Hills must waive its jurisdiction any time another Economic Development Corporation--in this case, Oakland County's--proceeds with an application for bonds.

A motion was made by Ambrozaitis, seconded by Yalamanchi, that this matter be Adopted by Resolution.

Whereas, Oakland Steiner School (the "Company") intends to acquire and preserve an historical building located in the City of Rochester Hills (the "Project"); and

Whereas, the Company is interested in pursuing the issuance of tax-exempt revenue bonds ("Bonds") through the Economic Development Corporation of the County of Oakland ("Oakland County EDC") as a means of financing its proposed Project; and

Whereas, the Oakland County EDC is currently active in assisting qualifying nongovernmental organizations through the entire process of issuing Bonds; and

Whereas, Act 338 of the Michigan Public Acts of 1974, as amended ("EDC Act"), requires a waiver of jurisdiction by the governing body of any municipality in which a project to be financed under the EDC Act is located if that municipality has an economic development corporation and the financing is to be undertaken by a different economic development corporation.

Resolved that, pursuant to the EDC Act, the Rochester Hills City Council hereby APPROVES the aforementioned waiver of jurisdiction with respect to the Company's Project to allow the Oakland County EDC jurisdiction to issue Bonds therefore.

Ms. Julie Jenuwine, Director of Finance, noted that the request before Council was for a six-month period as opposed to the typical one year. She explained that the six-month payment would put the contributions on the same cycle as the policy year, thus eliminating the need to estimate the contribution level. Additionally, she noted that she was seeking an increase to the self-insured retention (SIR) contribution as the City had drawn more funds than anticipated from the previous year.

PUBLIC COMMENT:

Mr. Lee Zendel, 1575 Dutton Road, questioned why the payment was not being identified as an insurance premium and questioned whether that payment is influenced by previous lawsuits against the City.

Ms. Jenuwine explained that it is not a typical insurance policy, but rather a self insurance program. She noted that various communities contribute funds to a pool of money from which Rochester Hills can draw when necessary; and that draw can result in an increase in the next year's contribution, as was the case with this contribution.

COUNCIL DISCUSSION:

Mr. Yalamanchi questioned whether the administration would be investigating alternative insurance coverage following the failure of MMRMA to support the City in a recent Consent Judgment case.

Mayor Barnett and **Ms. Jenuwine** explained that some investigation had taken place, but a more thorough investigation would likely require the use of an outside consultant. They noted some possible alternatives:

- The Michigan Municipal League (MML) offers similar coverage with more restrictions.
- There are no commercial policies that would meet the City's needs in its entirety, but rather various individual policies would have to be purchased.

Mayor Barnett noted that the MMRMA self insurance appears to be the most widely used among municipalities and that investigations of the MML insurance indicate that they would have made a similar decision in the case cited by Mr. Yalamanchi.

Mr. Yalamanchi requested that Ms. Jenuwine provide the research rather than the City pay for an outside consultant.

A motion was made by Duistermars, seconded by Raschke, that this matter be Adopted by Resolution.

Resolved that the Rochester Hills City Council hereby authorizes a Blanket Purchase Order/Contribution to the Michigan Municipal Risk Management Authority of Livonia, Michigan, to the self-insurance (general liability, motor vehicle physical damage, property and crime coverage) pool fund and self-retention fund replenishment in the amount not-to-exceed \$858,644.00 through June 30, 2007.
