SUBJECT: Shadow Woods Subdivision Road Rehabilitation Project – City File E06-023

REQUEST:

The Department of Public Service recommends approving a Professional Construction Engineering Services Agreement between Hubbell, Roth & Clark, Inc. (HRC) and the City of Rochester Hills for the Shadow Woods Subdivision Road Rehabilitation Project in a not-to-exceed amount of \$27,900.00 and authorize the Mayor and Clerk to execute a contract on behalf of the City.

REASON FOR PURCHASE:

In December of 2004, City Council approved the Professional Service Agreement with HRC for Municipal Engineering Services. HRC was selected through the quality base selection process as one (1) of the two (2) firms to provide engineering services to the City of Rochester Hills. HRC submitted a proposal to provide survey, layout, and staking services for the above-referenced project, as well as, assistance with construction inspection to supplement city staff on an as needed basis. The attached proposal includes an estimate of time and cost for the project.

BUDGET:

Costs associated with the Shadow Woods Subdivision Road Rehabilitation Project were identified in the Adopted 2007 Budget. The costs outlined in the attached proposal can be broken down as follows:

Survey, layout & staking - \$10,500.00 (MR-44, 100%) Construction Inspection - \$17,400.00 (LR-01, 72% or \$12,528.00), (MR-44, 28% or \$4,872.00)

HRC will provide the professional construction engineering services for this project, which includes, survey, layout & staking, and supplemental construction inspection, which will be charged to the project, along with outside consulting for materials testing and inspection. Approximately \$63,000 for material testing for local streets and \$25,000 for major roads will be expended to Spalding DeDecker from these balances.

Departmental staff will work with our consultant to oversee the direction of the survey, layout & staking, and supplemental inspection, as needed, on this project.

RECOMMENDATION:

It is recommended that City Council approve the Professional Construction Engineering Services Agreement between Hubbell, Roth & Clark, Inc. and the City of Rochester Hills for the Shadow Woods Subdivision Road Rehabilitation Project in a not-to-exceed amount of \$27,900.00 and authorize the Mayor and Clerk to execute a contract on behalf of the City.
