REQUEST:

That the Rochester Hills City Council approves the Washington Road Paving (East of Tienken to Dequindre) Preliminary Engineering Tri-Party Agreement between the Board of Road Commissioners for the County of Oakland and the City of Rochester Hills and authorize the Mayor and Clerk to execute the agreement on behalf of the City.

REASON FOR PURCHASE:

On March 28, 2007 the City of Rochester Hills received a notice from the Road Commission for Oakland County (RCOC) regarding their interest in beginning the preliminary engineering phase for the future gravel paving of Washington Road (East of Tienken to Dequindre). This section of Washington Road is in the Road Commission for Oakland County's (RCOC) 2030 Gravel Road Paving Plan. This project was identified in the 2008 Capital Improvement Programs (CIP) as MR-14, however, never rated because of the timing of the notice and because City staff was unaware the project was going to be proposed for 2010 and 2011 construction.

Tri-Party funds have been identified as a funding source for the project. Since Washington Road equally borders both the City of Rochester Hills and the City of Rochester, both communities will contribute one-third and RCOC and the County of Oakland will contribute two-thirds. The current estimate to complete the preliminary engineering phase of the project is \$170,000.00. Upon execution of the Agreement, the City of Rochester Hills will be invoiced for fifty-percent (50%) of the City's share or \$14,167.00. When the design work is complete, the actual cost of the design work will be determined and Rochester Hills will be invoiced accordingly.
