Chief Walterhouse advised the Committee of informational items:

- A purchase for a "fire demolition house" to be demonstrated to will be brought before Council in February. It will be purchased with 100 percent donated funds.
- Two (2) pumpers are due for replacement in 2005. However, the vendor, from which the 2003 pumpers were purchased, has issued a letter extending the 2003 price if the purchases are made in 2004, which would conservatively save \$60,000. Chief Walterhouse asked for the Committee's support before bringing the budget amendment before Council.

The Committee then made the following recommendation:

Member Raschke reported calls from residents that people are running the red light at eastbound Avon Road at Rochester Road. She also noted that the Clark Gas Station owner has requested that the Oakland County Sheriff Deputies lead drivers to Cloverport or another street rather than the Clark Gas Station when addressing drivers for possible traffic citations. Captain Smith noted that he will address the matters.

Captain Smith reported receiving a Federal Homeland Security Grant that will be used to develop a Citizen Emergency Response Team (CERT) program for residents to attend classes that address basic personal steps needed for homeland emergencies.
