Whereas, the City of Rochester Hills has been involved in Oakland County Community Development Block Grant (CDBG) projects since the programs inception in 1975. During this time period, over \$3.7 million dollars have been expended; and

Whereas, the City's proposed CDBG activities must meet the Department of Housing and Urban Development (HUD) regulations; benefit low and moderate income populations; prevent of eliminate slum and blighted conditions; or meet an urgent community need where no other source of funding is available; and

Whereas, the City of Rochester Hills City Council held a public hearing on May 5, 2004 on the reprogramming of Program Year 2002 funds of \$30,000 from Removal of Architectural Barriers (Activity Number 2400) to Parks / Recreational Facilities (Activity Number 3436);
