Proposed Road Name Change of Gulch Court to Silver Creek Court

**..body**

**Whereas**, the City Council of the City of Rochester Hills on Wednesday, May 19, 2004 did by resolution deem in advisable and declare its intention to rename the following described street, alley, public ground or part thereof, located in the City of Rochester Hills, and subject to the jurisdiction and control of the City of Rochester Hills:

The property located in the southwest quarter of section 3, T.3N., R.11E., City of Rochester Hills, Oakland County, Michigan, more particularly described as: Gulch Court, 60 feet wide, part of the "Hillside Creek Subdivision" as recorded in Liber 280, Pages 2 through 6, inclusive of Oakland

County Register of Deeds.

**Whereas**, in accordance with the Code of Ordinances of the City of Rochester Hills, Chapter 94-144-94-170, The City Council has held a public hearing and has heard and considered any comments or objections pertaining to such renaming, discontinuance or abolition; and

**Whereas**, the City Council determines it is necessary for the health, welfare, comfort and safety of the People of Rochester Hills to rename the above-described street, alley, public ground or part thereof;

***Now, Therefore, Be It Resolved:***

1. That the above-described street, alley, public ground or part thereof shall be renamed;
2. That the current name of Gulch Court shall be known in the future as Silver Creek Court;
3. That the City Clerk is hereby directed to, within thirty (30) days, record a certified copy of this resolution with the Oakland County Register of Deeds, and to send a copy to the State Treasurer, as required by statute;
4. That, upon being (but not until) so recorded, this resolution shall have the force and effect of vacating, discontinuing or abolishing the described street, alley, public ground or part thereof.
