### **PURPOSE:**

Authorization for construction services for vault toilets and accessible pathways at Veterans Memorial Pointe and Bloomer Park for Cedroni Associates, Inc., Utica, Michigan in the amount not-to-exceed \$95,406.00 with funds provided by the Community Development Block Grant Program.

## **DISCUSSION:**

The vault toilets and accessible pathways are part of ongoing Park improvements projects identified in the City's Capital Improvement Plan as PK18, Outdoor ADA requirements, and PK19, Vault toilets. These projects will be funded through the Community Development Block Grant program. The vault toilet at Veterans Memorial Pointe will provide accessible restroom facilities that are not available now and will also serve the Clinton River Trail users. The vault toilet at Bloomer Park will provide a year-round accessible restroom for park users. Currently, during the late Fall and through early Spring, the water is turned off to the restrooms. The only facilities available to park users are vault toilets in the woods that are not accessible, difficult to find and cannot be cleared of snow.

The pathway for Bloomer Park will connect the parking lot at the Hilltop Shelter warming area to the top of the sledding hill. The pathway at Yates Park will provide an accessible route to the edge of the Clinton River.

Bids were opened on June 22, 2004, with Cedroni Associates, Inc., Utica, Michigan providing the lowest, responsive, and responsible bid in the amount of \$76,278.00. We are also recommending that we accept Alternate 1 to change from a single vault to a double vault for an additional \$14,950 and Alternate 2 to upgrade the style of the building for an additional \$4,178 for a total amount of \$95,406.00.

# FISCAL INFORMATION:

There will be a minimal increase in maintenance costs. There will be no staff added because of these improvements.
