**SUBJECT:** Snow Removal Services 2012-2013 Winter Season

# **REQUEST:**

City Council is requested to authorize the issuance of a blanket purchase order to Ultra Professional Outdoor Services, LLC, 2431 Pontiac Road, Auburn Hills MI 48326 for snow removal services for the 2012-2013 winter season at the City Hall, 52/3rd District Court and Oakland County Sheriff's Office Substation in the amount not-to-exceed Seventy-Five Thousand (\$75,000) Dollars through June 15, 2013.

# **REASON FOR PURCHASE:**

The City of Rochester Hills wishes to exercise its option to renew for an additional one (1) year term pursuant to the terms of the proposal.

It is important to the City to provide a safe environment for persons accessing City buildings during the winter months. Competitive sealed proposals were solicited for Snow Removal Services and opened on June 29, 2011. Ultra Professional Outdoor Services, LLC, 2431 Pontiac Road, Auburn Hills, MI 48326 was selected as the vendor providing the best value and lowest cost proposed for 2011-2012 winter season snow removal services for the City at three (3) City owned facilities.

The three (3) City owned buildings that the Service Company will be responsible for are as follows:

Location #1: Rochester Hills Municipal Offices (City Hall), 1000 Rochester Hills Drive, Rochester Hills

Location #2: 52/3 District Court, 700 Barclay Circle, Rochester Hills

Location #3: OCSO Substation, 750 Barclay Circle, Rochester Hills

Snow removal at remaining City facilities will be completed by City personnel. The City has the option at any time during the term of the contract to delete buildings and/or services.
