SUBJECT: Extension of Comcast Wide Area Network and Internet Services Blanket Purchase Order

REQUEST:

City Council is requested to authorize an eight (8)-month extension for the existing blanket purchase order authorized in 2005 for an amount not to exceed \$40,000.00, while the City pursues the bidding and/or renegotiating process for these services.

REASON FOR PURCHASE:

In November of 2005, City Council authorized a three (3)-year blanket purchase order for Comcast Commercial Services, Inc. in the amount not to exceed \$154,000.00 through December 31, 2008. Comcast has agreed to maintain the current monthly service charge on a month-to-month basis through June 30, 2009 to facilitate the bidding and/or renegotiating process for these services. Therefore, the MIS Department requests that Council approve an extension of the existing blanket purchase order for the duration of this period in the amount of \$40,000.000.
