Dear City Council:

Pursuant to the City Council's direction, I have prepared and enclose, for second reading, a revised version (dated 07/30/04) of the proposed ordinance to amend Section 134-107 of the Code of Ordinances to modify regulations governing the discontinuation and amortization of nonconforming signs. Please note that this revised version differs from the version presented for first reading in that I have deleted from the third sentence of subsection 134-107(5) the December 31, 2010 compliance deadline. No other changes have been made. Please note that, as usual, terms being deleted are stricken through, and terms being added are underscored. For an unknown reason, the version that appeared in the CD for the City Council's July 28 meeting omitted the strike throughs and underscoring.
