7C. PUBLIC HEARING - FILE NO. HDSC 07-003

Location: 56187 Dequindre Road, located west of Dequindre Road, south of Carter Road, and which is adjacent to the northern border of the City of Rochester, further identified as Parcel Number 15-01-278-005, zoned R-1 (One Family Residential).

Purpose: To receive public comment regarding a proposal to eliminate the subject property as a Historic Districts within the City of Rochester Hills, in accordance with Public Act 267 of 1976 (MCL 15.261 et seq., MSA 5.3407(3) et seq.) and the Rochester Hills Historical Preservation Ordinance, Section 118-134.

Chairperson Thompson read the location and the purpose of the Public Hearing for the record. He explained the duties of the Historic Districts Study Committee per Section 118-130 of the City's Historic Preservation Ordinance, which include:

- (1) Conducting a photographic inventory of the resource;
- (2) Conducting basic research of each historic district or resource;
- (3) Determining the number of historic and non-historic resources.

Chairperson Thompson stated that in 2002 Dr. Jane Busch conducted an Intensive Level Survey of all historic and potential historic resources within the City. On January 22, 2003, the Historic Districts Survey was presented to City Council.

Chairperson Thompson stated the procedure the Study Committee followed for the elimination of a District per Section 118-134 of the City's Historic Preservation Ordinance was to prepare a Preliminary Report, hold a Public Hearing, and then prepare a Final Report showing one or more of the following criteria:

- (1) Lost physical characteristics (the historic district has lost those physical characteristics that enabled establishment of the district), or
- (2) Insignificance (the historic district was not significant in a way previously defined), or
- (3) Defective procedure (the historic district was established pursuant to defective procedures).

Chairperson Thompson stated that the Preliminary Report was transmitted to the State Historic Preservation Office on June 29, 2007, for review and comment. Comments have not been received as of this date. He stated a copy of the Preliminary Report had been mailed to the property owner on June 29, 2007. He noted copies of the Preliminary Report were available at the back of the auditorium for the public to review.

Chairperson Thompson stated that per Ordinance the Study Committee was required to hold a Public Hearing not less than 60 days after transmittal of the Preliminary Report to the State Historic Preservation Office. Pursuant to Public Act 267 of 1976 (the Open Meetings Act), notice of the Public Hearing was mailed to the homeowner of record on August 31, 2007, and a Notice was published in the Rochester Eccentric on September 2, 2007, at least 14 days prior to the Public Hearing.

Chairperson Thompson explained the information received at this Public Hearing would be included in the Historic Districts Study Committee Final Report for the property commonly identified as 1207 N. Livernois Road, which Report would be presented to City Council within one (1) year after the date of the Public Hearing, along with a draft proposed Ordinance.

Chairperson Thompson opened the Public Hearing at 5:49 PM. He reminded those in attendance that the purpose of the Public Hearing was not to debate or discuss the potential elimination of the property as a historic district, but to allow the public to place their comments or concerns on the record.

Melinda Hill, 1481 Mill Race, stated that even though she did not like to see a resource be eliminated or removed as a historic district, she thought this was an appropriate situation. She commented that after a review of the existing districts performed by Dr. Busch, that the Study Committee had done the work on the properties recommended by Dr. Busch to be delisted or

eliminated as historic districts. She stated the Preliminary Report was well done and thanked the Study Committee for their work. She agreed this was the appropriate action to be taken.

Chairperson Thompson called for any other public comments. Upon hearing none, he closed the Public Hearing at 5:51 PM.
