







# **BUTLER RIDGE NO. 2**

ALL MONUMENTS SET AND FOUND ARE MADE OF SOLID STEEL BARS 1/2" IN DIAMETER AND 36" LONG AND COMPLETELY ENCASED IN CONCRETE 4" IN DIAMETER. NO I.D. CAPS ARE USED.


