Certain questions have arisen concerning the new facility (Center) of the Older Persons Commission located in the City of Rochester. It is operated under an Interlocal Agreement entered into in 1983 between the then Township of Avon, Oakland Township and the City of Rochester.

The current questions pertain to whether the Center may serve non-residents, on some basis, and whether persons under the age of 60 may use the facility.

Enclosed is a copy of a letter of opinion I wrote to the Older Persons Commission dated October 29, 2003. Also enclosed is a copy of the Amended and Restated Interlocal Agreement. As stated in my letter, two amendments of the Amended and Restated Agreement are not relevant to the pertinent questions.
