Your current contract and blanket Purchase Order #400593 expires on February 14, 2004. The City of Rochester Hills is pleased with your job performance and response time. Man-Con and the City have established a good working and verbal relationship. Therefore, we would like to extend Man-Con's current contract for an additional year, with the following clarifications:

- 1. Equipment and labor costs will remain firm for the additional year.
- 2. Materials/miscellaneous items will be paid at supplier price plus 15%.
- 3. Only rental equipment shall be compensated at supplier price plus 15%.
- 4. Mobilization fees will be incurred only on rental equipment, and the supplier's invoice must indicate this charge separately. The plus percentage will not be added to this fee.
- 5. Complete accurate daily records of costs must accompany contractor's payment requests.

Under the current contract, Man-Con obtained the required insurance coverage requested by the City of Rochester Hills, and that coverage expired on January 1, 2004.
