SUBJECT: Permit Guide and Virtual Inspection Tool

REQUEST:

City Council is requested to authorize the issuance of a contract / blanket purchase of a Permit Guide and Virtual Inspection Tool to Camino, Inc., 2261 Market Street #4302, San Francisco, CA 94114 in the amount of \$10,000.00 per year for a not-to-exceed of \$30,000.00 for a three year term to expire April 30, 2025.

REASON FOR PURCHASE:

Camino is a virtual inspection program that will allow our customers and inspectors the option to perform virtual inspections using any device. Camino's Virtual Inspection solution is 100% hosted and does not require any dedicated hardware or software to work. As long as the inspectors have a microphone on their computers or laptops, they can start using the tool. Inspectors do not need to travel onsite, helping save money on gas, equipment, and personnel. Inspections can be conducted remotely at any place and at any time, with no app downloads required. The entire inspection is recorded and stored securely in the cloud.

The Camino Guide, another feature this program provides, is an informational resource that serves as a virtual 'pre-meeting' for anybody thinking about starting a building project. After first answering a series of questions, applicants will automatically receive a customized guide containing their timeline, fees, and process for successful project completion. The Guide will also integrate with existing GIS systems to let the applicant know whether their project is allowed in the selected zoning.

The City utilizes cooperative contracts that can meet the requirements of the Purchasing Department as a resource for savings. Omnia Partners in conjunction with Fairfax County, VA as the lead agency issued and awarded a competitive solicitation to Insight Public Sector, Inc. for Technology Products, Services, Solutions and Related Products and Services. Camino, Inc. is one of available suppliers of the technology products listed under the cooperative contract. In evaluating the purchase of this item, the City evaluated other cooperative contract pricing and determined the Omnia Partners cooperative program was the lowest cost available and recommend award of the permit guide and virtual inspection tool to Camino, Inc.

The annual cost is \$10,000.00 per year for a not-to-exceed total of \$30,000.00 for the three year term.
