#### **PURPOSE:**

City Council is requested to authorize the issuance of a blanket purchase order to the Road Commission for Oakland County for the maintenance and repairs or upgrades of existing traffic signals, SCAT costs and school flashers in the amount of \$100,000.00.

## **DISCUSSION:**

Under the terms and conditions of separate agreements with the Road Commission for Oakland County, the City of Rochester Hills has agreed to pay for a percentage of costs associated with maintaining traffic signals within the City limits. The actual cost to maintain and/or repair traffic signals can very significantly from month to month. The actual costs include electricity, labor, equipment and materials.

In 2004, the City began providing better night visibility and improving safety for the residents at traffic signal intersections through a new advanced technology an energy efficient light emitting diodes known, as LED. During 2005, the City will continue to evaluate the future upgrades for LED safety improvements of City intersections.

In order to process payment for the next year's traffic signal maintenance and repairs or upgrades obligation and any possible needs for LED traffic signal upgrades, the Department of Public Service requests approval of a blanket purchase order in the amount of \$100,000.00.

#### **FISCAL INFORMATION:**

Costs associated with the traffic signal maintenance were identified in the 2005 annual operating budget in the amount of \$100,000.00.

An engineering aide will review the invoice and a clerical staff member will process invoices for payment.
