PURPOSE:

A blanket purchase order not to exceed \$130,000 for labor and employment related legal services from Kemp, Klein, Umphrey, Endelman & May P.C. (KKUE) from January 1, 2005 through December 31, 2005 is requested.

DISCUSSION:

Thomas L. Boyer has served the City of Rochester Hills for over 29 years. His dedication and unique historical perspective continues to add value to his role as the City's principal attorney for labor and legal matters.

Labor and employment related legal activities for 2005 will include ongoing contract negotiations with the fire fighter union, and negotiations with the general employee union, AFSCME Local #2491. Research and analysis in areas such as active employee and retiree health insurance, and coordination with pension plan changes will be addressed. Other matters anticipated include grievances, administrative and personnel policy matters, and privatization. Compliance issues relative to legislation such as the Fair Labor Standards Act, the Family and Medical Leave Act, Title VII and the Americans with Disabilities Act are also generally anticipated.

FISCAL INFORMATION:

The amount requested represents a five percent increase over the equivalent 12-month period for 2004. The increase is necessary due to an increase in the rate for Mr. Boyer and other KKUE attorneys from \$135 to \$140 per hour. This increase should be considered modest in light of the fact that the hourly rate has not increased since 2002 and the overall amount requested is still 17% less than the total blanket purchase authorization for 1999.
